## About Cookies and Similar Technology

A "cookie" is a small, often encrypted text file, located in your web browser directory. The text in a cookie often consists of a string of numbers and letters that uniquely identifies your computer, but it can contain other information as well. The website can send its own cookie to web browsers if browser preferences allow it. Similar technologies are also often used within emails to understand whether the email had been read and if any links have been clicked.
